The TFA Registration department has contracted with Business Information Group (B.I.G.) to administer fingerprint services for new recruits and administrators. This new vendor is recognized by FINRA and transmits directly to the F.B.I. They have 700+ locations nationwide and offer Live Scan, an electronic fingerprint.

This new relationship has also reduced the costs for the fingerprint service. B.I.G. locations will only charge \$17.50 to collect prints for your new recruits and administrators.
